This announcement is made by the board of directors (the “**Board**”) of Dongyue Group Limited (the “**Company**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

Shandong Dongyue Organosilicon Materials Co. Ltd. (山東東岳有機硅材料股份有限公司) (“**Dongyue Organosilicon**”, stock code: 300821.SZ), a non-wholly owned subsidiary of the Company listed on the ChiNext of the Shenzhen Stock Exchange, has published its results preview for the first three quarters of 2025 (the “**Results Preview**”) on the website of the Shenzhen Stock Exchange.

As stated in the Results Preview, Dongyue Organosilicon’s net profit attributable to its shareholders for the nine months ended 30 September 2025 is estimated to decrease by approximately 96.27% to 97.40% year-on-year; and its net profit after non-recurring profit or loss is estimated to decrease by approximately 87.10% to 88.14% year-on-year.
